

## Chrystals Little Treasures Spay/Neuter Pet Puppy Contract

Revised April 23, 2015

This agreement is made and entered on \_\_\_\_\_ (Date) by and between **Chrystal Rackley** (Seller), and \_\_\_\_\_ (Buyer), for the purpose of setting forth the terms and conditions of purchase by the Buyer of a purebred **Jack Russell Terrier AKA Russell Terrier** from the whelped on \_\_\_\_\_ out of \_\_\_\_\_ & \_\_\_\_\_

Seller warrants that the above described puppy/dog is a purebred **Russell Terrier** registered **American Kennel Club aka AKC**.

### Payment Terms

**ALL PAYMENTS ARE TO BE CASH OR MONEY ORDER, NO CHECKS WILL BE ACCEPTED**

The seller agrees to sell and the buyer agrees to purchase a female \_\_\_\_\_, male \_\_\_\_\_ companion puppy from the litter described above subject to the following terms.

Ownership of the puppy/dog will be transferred to the buyer for the sale price of \$\_\_\_\_\_ to be paid as follows: **\$500 Nonrefundable Deposit** on execution of the agreement with the balance of \$\_\_\_\_\_ to be paid on or before the puppy/dog leaves the sellers premises.

- a) Deposit guarantees your pick of puppy which will be held until 16weeks of age. (Unless other arrangements have been made). After 16 week the puppy/dog will belong to CLTRussells and will be offered for adoption, No refund will be given
- b) Deposit is only refunded in the event of the puppy/dog's death or illness before the puppy/dog leave sellers' premises.

### General Terms

**No Cosmetic Alterations after the dog/puppy leaves CLT.**

The Seller has determined that the puppy/dog is of "pet quality" and is NOT suitable for breeding. In such case, Seller shall provide Buyer with Limited Registration Certificate.

**Buyer is required to Spay/Neuter this puppy/dog at buyers' expense.**

- a) Seller agrees to refund to buyer the sum of \$50.00 upon receipt of spay/neuter certificate from a licensed Veterinarian before the puppy/dog reaches the age of one year old.
- b) Veterinarian maybe contacted for verification.
- c) UKC Registration Papers (if applicable) will be held until Prof of spay/neuter has been provided.

Seller agrees to refund to buyer the sum of **\$50.00** upon receipt of spay/neuter certificate from a licensed Veterinarian. **Registration Papers will be held until Prof of spay/neuter has been provided.**

Puppy/dog will carry the "Chrystals Little Treasures" kennel name by having the "CLT" Prefix at the beginning of its registered name.

For Example: "CLT Lil Ray of Sunshine", or "CLT He's A Rock N Roller"

Buyer agrees that he/she is not acting as an agent in the purchase or this puppy/dog and that Buyer will not sell this puppy/dog or its progeny to any agent, pet store or guard dog business.

Buyer agrees that if it becomes necessary to sell or otherwise dispose of this puppy/dog, Buyer will notify the Seller before taking such action so that the puppy may, at the Sellers' option, be re-purchased by the Seller at the original sale price. Upon notification, the Seller shall have 15 working days to exercise said re-purchase option. Exercise shall be notice in writing sent to Buyer.

Buyer agrees that the puppy will reside at the home of the Buyer, have access to a fenced yard, not be chained or tethered, and will be provided with proper housing, a good quality diet, annual shots and exercise. Buyer also agrees that this puppy/dog will not be used as a guard dog for any business.

Buyer agrees that, at least, one basic obedience training course will be completed with the puppy/dog. Buyer understands that it is their moral and financial duty to maintain and care for this dog for the rest of its life.

The buyer agrees to maintain the dog's health in good condition, and provide yearly examinations, vaccines, parasite treatments, and any other usual procedures necessary to assure good health. Dog must visit a licensed vet for a rabies vaccination. Buyer may choose to give their own routine shots, worming, and flea/tick treatments.

Buyer agrees not to take seller to court for any reason and will resolve any issue that arises outside of court.

There is no guarantee on the temperament of this puppy, as there are many factors in life that will affect him/her, such as methods of training, amount of time spent with the puppy, socialization of the puppy, etc..

Buyer is to notify Seller of any and all Change of Address and/or phone number.

### **Health Guarantee**

Seller warrants that the above-described puppy/dog is in good health at the time Buyer assumes ownership.

**Buyer agrees to have the puppy examined by a licensed Veterinarian with 72 hours of receipt of puppy/dog.** If buyer chooses not to take dog/puppy to a licensed veterinarian within 72 hours of acceptance, all guarantees are null and void. After 72 hours the only warranty the dog is covered is the congenital defect.

Seller does not assume any liability for any injury or sickness contracted after the 72 hours of receipt/delivery/pickup of dog (this includes parasites, protozoan, and parvovirus infections). Buyer is advised to send seller a copy of the vet finding from this initial exam.

If, as a result of the examination, the Veterinarian determines that the puppy/dog is not in good health then the Buyer shall elect to keep the puppy/dog or return the puppy/dog to the Seller for a refund.

- a) **Return Puppy:** If the buyer elects to return the puppy, Buyer shall, within 10 days after the date of receiving the puppy, send to Seller by certified mail a written Veterinarian's certificate stating that the puppy was in ill health when examined Upon receipt by Seller of said certificate, Buyer shall be obligated to return the puppy/dog to Sellers at Buyers expense. All action taken to return the puppy/dog shall be done with the best interest of the puppy/dog in mind includes temperature

at time of shipment, non-stop flights, etc. Buyer shall be solely responsible for all cost and related expenses of returning puppy to Seller.

- a. Refund: Upon receipt of the puppy/dog, the Seller shall be obligated to refund less the \$500 non-refundable deposit received from Buyer toward the purchase price of the puppy/dog, and further performance under this contract shall be null and void.
- b. Puppy Exchange: Buyer may select to exchange the puppy for another from current or future litter.
- b) Keep Puppy: Should buyer decide to keep puppy/dog he forfeits all claims and shall be solely responsible for any and all future Veterinarian bills for puppy/dog. No refund will be given.

We offer a one year replacement guarantee against life-threatening genetic defects which result (or may result) in death or in its having to be humanly euthanized.

Buyer understands that taking the puppy/dog out into public places before receiving the full series of vaccinations (usually finished by 16 weeks old), will put it at risk of contracting contagious diseases.

Seller is not responsible for any illness or death that results from the dog being exposed to disease by the buyer.

Seller makes no guarantee regarding loss of the dog because of accidental death, theft, sickness, etc or any other loss beyond the seller's control.

This guarantee does not cover, what we consider normal or beyond our control: skin allergies, giardia, coccidia, parvo, worms, parasites, viral or bacterial infection, corona, distemper, heartworms or any nutrition related diseases.

Buyer understands the need for caution and action on their part to protect puppy/dog from virus' parasites, protozoa's, and other diseases. The buyer agrees to provide the puppy the proper vaccinations and to refrain from exposing the puppy to parks, pet supply stores, groomers, other dogs, walks down the street, beach etc. until the puppy is 16/18 weeks of age or when the vet says the puppy has completed the puppy vaccinations.

Once puppy/dog leaves us, we are not responsible for worms, parasites, protozoa's, and the deadly Parvo Virus. This puppy/dog will have preventative care against these health issues before they leave. There is no guarantee that this puppy/dog is 100% protected and that they can still get these.

**Should Buyer choose to break any of the above portions of this agreement, the remainder of the agreement will be considered null and void, and breeder will have the right to repossess puppy. Giving permission for breeder or their representatives to come onto buyers' property and take back the puppy/dog. No refund will be given.**

This Agreement is made and signed by both parties to insure the well being and protection of this puppy/dog. If the Buyer breaches any part of this Agreement, the Seller is released from any obligations under this Agreement.
